<p>Are there services covered before you meet your deductible?</p>	<p>Yes. Does this plan provide Minimum Essential Coverage? Yes

This is not a cost estimator. Treatments shown are just examples of how this [plan](#) might cover medical care. Peg is Having a Baby
(9 months of in-network pre-natal care and a hospital delivery)

- Primary care physician office visits (*including disease education*)
- [Diagnostic test](#) (*blood work*)
- Prescription drugs
- [Durable medical equipment](#) (*glucose meter*)
